- Pre-School instructor, Tiffany Richmond has notified me that our pre-school program has successfully completed a renewal inspection and that a renewal will be issued.
- Preliminary release of our Annual Performance Report (APR) Data will be September 26th, 2019 and final APR's are set to be released on October 10th, 2019.
- The district has successfully completed requirements of a wellness incentive offered by the district's health insurance provider. We have received \$1,040 to be used to promote health and wellness initiatives for employees.
- The Missouri School Boards Association annual conference will be September 26th 29th, I will be attending this year's conference.
- Cass County Kids First will be meeting October 2nd at the Raymore-Peculiar School District to discuss and establish the group's legislative platform for the upcoming year.
- Facilities/Construction Project Updates:
 - KCP&L Rebate paperwork has been completed and submitted on the LED Lighting Retro-fit given that our rebate will be just under \$15,000 they will conduct a post-installation inspection on September 9th before the rebate payment is issued.
 - o Windows installation of one window (broken in transit) remains to be installed on 9/9.
 - O Roofing Washington Roofing was here on 8/23 doing some of the touch up work on the roof coating work. The roofing consultant and factory warranty rep. from GACO Western are working to confirm a date to conduct a warranty inspection. We are retaining 5% (\$6,000) of their final payment until we have the okay from the consultant and warranty rep. that the work is satisfactorily completed.
 - o HVAC Heartland Mechanical has completed their scope of work.
 - O Retaining Wall the retaining wall block has been laid, at this time all that remains is to use some gravel to backfill between the blocks and once that is completed we will clean the top of the block before applying the adhesive and the capstone to finish it off.
 - Other coordinating with the mason to complete tuck pointing of brick exterior in five locations, Lexicon to correct termination at roof hatch. This month's pay application to McKinstry is in the amount of \$72,788.00. They will be on-site for a walk-through on 9/17. At this point, until all projects are completed and approved, we are retaining around \$55,000 of final payment to McKinstry.
 - Once these projects are finalized and Phase I Projects are closed out the district will begin planning for Phase II Projects.
