Operations Updates:

- Facilities
 - o North Gym RTU fan motor and one of the compressors will need to be replaced.
 - o Kitchen RTU circuit board has failed, trying to locate replacement to be able to make this repair.
- Food Service
 - August Served 720 Breakfasts = 103/day
 - August Served 1064 Lunches = 152/day
- Health Services
 - August Office Visits = 193. Six students sent home.
 - o Cass County Dental Clinic will be here September 29th, 2023 to provide free dental screenings to all of our students K-12th grades.
 - Darrah will start vision and hearing screenings on students the first week of September.
 - Darrah certified 22 staff members/coaches in Heartsaver/CPR. We have a total of 33 staff members who are currently certified with plans to teach more CPR classes on PD days as needed.
- Transportation
 - o North Route
 - AM Averaging 6-8 riders 45-minute ride time.
 - PM Averaging 8-10 riders 40-minute ride time.
 - South Route
 - AM Averaging 26-28 riders 50-minute ride time.
 - PM Averaging 22-24 riders 45-minute ride time.
 - Vo-Tech Route
 - Sharing ride with Archie again this year sending four students to Cass Career Center in Harrisonville.
- Technology
 - New Wireless Access Points and Switches were installed just prior to the start of the school year. With the installation of a new server this summer – our infrastructure is in good shape. New chromebooks have been distributed to students.

Facilities Planning Committee Updates:

The facilities planning committee is scheduling meetings for this fall to discuss possible projects and financing for a potential general obligation bond issue for the April 2024 ballot. The first meeting was held August 23rd and the second meeting was held September 13th. There are plans to hold one more meeting on October 4th to finalize recommendations to the board at the October 16th board of education meeting.
